The Camden-Wyoming Sewer and Water Authority (CWS&WA) met at the CWS&WA Conference Room on March 10, 2020. The meeting was called to order at 7:03 p.m. by the Chairperson, Mr. Ridgely.

### Agenda of the Special Meeting

Mr. Ridgely indicated that the purpose of the Special CWS&WA meeting was the discussion of sanitary sewer service connection for 121 Wilder Road, Tamarac.

## Approval of the Agenda

Motion:

Mr. Winchell made a motion to approve the Special Meeting Agenda, seconded

by Mr. Girty. Motion carried unanimously.

# Discussion regarding the Special Meeting Agenda

It was noted that the homeowner at 121 Wilder Road, Tamarac, had not filed an Application with the Authority for sanitary sewer services.

Gharebaghi explained the process through which the Authority's services were made available to applicants for CWS&WA's sewer and water utility services. Upon receipt of an Application, properly executed by the property owner of record, and filed with the Authority for the Authority's services, CWS&WA could investigate (on a case by case basis in Tamarac) whether the property of the homeowner / Applicant could physically, and at a reasonable cost, be connected to the CWS&WA's existing infrastructure, Gharebaghi added. In the case of Tamarac, the existing infrastructure at Barclay Farms sanitary sewer system, could potentially serve as a discharge at the existing manhole #1 at Barclay Farms, near the existing pond there, Gharebaghi continued.

At the request of a property owner, a Technical Feasibility Analysis (TFA) could be performed, identifying the ways and means of connection to the Authority's sewer and water infrastructure, advising the property owner regarding the TFA, Gharebaghi said.

Mr. Scott recommended the development of a sanitary sewer improvements project for the entire Tamarac subdivision.

Mr. Ridgely asked the five visitors, who were residents of Tamarac, to indicate their interest in such a project by show of hands. No one raised their hands.

After discussion of the matter, the Board decided the following:

A Workshop Session convened at the CWS&WA Conference Room, on January 28, 2020. The Authority's sanitary sewer and water distribution system projected projects were prioritized and ranked. Priority 1 projects were discussed for implementation in FY 2020-21 as short term projects. Intermediate projects were identified to be implemented in 3 years and long range projects in 5 years, or longer, depending on development activities and circumstances.

The Camden-Wyoming Sewer and Water Authority (CWS&WA) met at the CWS&WA Conference Room on January 28, 2020 for a Workshop Session. The meeting was called to order at 7:00 p.m. by the Chairperson, Mr. Ridgely.

Mr. Ridgely indicated that the purpose of the Workshop Session was to consider and rank Projected Projects, as well as, befittingly fund Capital Projects; reflected in the Authority's Fiscal Year Budget.

Gharebaghi provided an overview of current projects and issues on which the Authority Operations was working:

1. 1 MG elevated water storage tank - at the Upper King Road facilities - paint failure. In this regard, Gharebaghi indicated that representatives of the paint manufacturer, Enduron, and the Authority's tank maintenance contractor, Corrosion Control Corporation (CCC) had met at the site. Enduron assured the Authority, in writing, that they were aware of the incompatibility of the paint and it's sublayer in the paint system, and Enduron would work with CCC to present the Authority a proposed fix for the 1 MG tank. After the review and approval of the Authority's Operations, work to correct the paint failure would begin some time after April of 2020, weather permitting. Enduron has accepted full responsibility for the failure and the proposed fix.

### 2. King Residential Development,

Gharebaghi indicated that he had met the Director of Kent County Department of Public Works (KC DPW) and her assistants. He said that the KC DPW had agreed to take the entire King Residential Development out of the County's Sewer District One (1) since the property was within the incorporated limits of the Town of Camden. As such, the Authority would be the sewer and water services provider. KC DPW has also revised the County's Technical Feasibility Study (TFS) to reflect the above. The County's revised TFS was transmitted to Davis, Bowen and Friedel (DB&F) - engineers of record for the proposed development activities.

### 3. Kent County Billing Issue Update,

Gharebaghi indicated that he had been working with KC DPW Director toward reaching an amicable and fair solution to the County's billing practices as relates to the County's metering Station #14B.

# 4. Certificate of Public Convenience and Necessity (CPCN) Matter,

Gharebaghi presented sensible arguments with respect to the Authority's Service Territory. The health, safety and welfare of the public should be included in the Public Service Commission's (PSC) considerations when granting CPCN's, he continued. Gharebaghi indicated that he would work with the Authority's Attorney, if necessary, to bring to light the fact that CPCN's were licenses to serve water utility services, not ones to be held as though assets. While no improvements have ever been made in the CPCN area of the water purveyor who holds the area's CPCN's. Again, the health, safety and welfare of the public should trump any impact CPCN's might have on the stock value of a for-profit water purveyor. The issue of the safety of the Nellie Stoke's Elementary School was also discussed.

After discussion surrounding the above, the <u>Summary of Projected Projects</u>, <u>Sanitary Sewer and Water Distribution Systems</u> was considered. The revisions to the ranking of the projects since the document's last update were considered and are shown on the attached <u>Summary of Projected Projects</u>, <u>Sanitary Sewer and Water Distribution Systems</u>, last updated on March 26, 2020.

Mr. Kenley indicated that the Town of Wyoming's Second and Third Streets had not yet been overlaid. Mr. Kenley also indicated that he would advise the Authority when pavement overlay was scheduled.

The Workshop Session adjourned at 8:15 p.m.

The Camden-Wyoming Sewer and Water Authority (CWS&WA) met at the CWS&WA Conference Room on January 14, 2020. The meeting was called to order at 7:10 p.m. by the Chairperson, Mr. Ridgely.

### Approval of the Consent Agenda:

Motion: Mr. Ness made a motion to approve the Consent Agenda, seconded by Mr. Girty.

Motion carried unanimously.

### Maintenance & Operations Status (Superintendent Report):

Mr. Scott indicated that the Operation and Maintenance Reports for October, November, and December of 2019, had been emailed to the Board Members and discussed the Reports. Mr. Scott indicated that the CWS&WA Office Renovation Project had been substantially completed - about 90% he estimated. Mr. Scott also indicated that the drive through window - for receipt of payments, and the like - was open for business. A night drop box was also in operation, adjacent to the drive through window, Mr. Scott added.

Mr. Scott anticipated that site work would be performed by the Authority's crews at 12 S. West Street, property adjacent to the Authority's Office, weather permitting.

Mr. Scott indicated that, in addition to routine pump stations' wet well cleaning, the Authority's crews had removed the pumps from the Tamarac pump station. The pair of pumps had been pulled out of the wet well to be sent away to Deckman Electric in Pennsylvania for repairs. While the Tamarac pump station's pumps had been removed for repairs, the Authority's crews had set up a by-pass pump, Mr. Scott added. Mr. Scott noted that the by-pass pump would be disassembled and the repaired pumps reinstalled in the very near future.

Regarding Tidbury Crossing, the residential land development between Lowe's and Upper King Road - along Lochmeath Way, Mr. Scott indicated that 17 additional building permits had been issued by the Town of Camden there. Mr. Scott noted that the new homes' construction would have a positive effect on the Authority's impact fees' accounts.

## Maintenance & Operations Status (Superintendent Report, cont.):

Mr. Scott indicated that the Town of Camden had approved a 192-unit apartment complex within the King Residential Development, between Town Hall and the King Commercial Development.

Mr. Scott indicated that the Authority's current system balance was \$377,626. Mr. Scott indicated that the Authority's bills, through the end of December of 2019, had been sent to CWS&WA Customers. He also said that \$191,760 had been collected and \$39,000 in commercial billing had been sent out to CWS&WA's commercial account holders. Mr. Scott indicated that the Authority would not be shutting off water services to delinquent account holders' houses in consideration of winter weather conditions.

The Authority's accounts receivables (AR), aging longer than 180 days, were approximately \$55,229, Mr. Scott added.

Mr. Scott presented the Authority's financial audit to the Board Members and indicated that, according to the Authority's financial auditors, Dingle and Kane, the audit had been "clean" and there had not been any "red flags."

Mr. Ness made a motion to confirm the Board's acceptance of the Authority's Financial Audit Report, prepared by Dingle and Kane, as presented, seconded by Mr. Winchell. Motion carried unanimously.
